INSTRUCTIONS AND INFORMATION  
FOR A  
BONDED CERTIFICATE OF TITLE FOR A MOTORBOAT

If your county official cannot register or title your motorboat because you do not have the proper title documents, you **may** be able to file a bond as a condition of obtaining a title.

1. If there is an **owner of record**, a return receipt from a certified letter to the owner of record at the last known address stating that the applicant(s) is the present owner of the motorboat and requesting a duplicate title with an assignment to the applicant(s). The owner of record must be allowed thirty (30) days to respond. The applicant shall submit a copy of the letter and return receipt to the DMV.
2. **Any written document** that you received at the time the motorboat was acquired, such as a bill of sale or a cancelled check. An affidavit may also be accepted. The document(s) will not be returned.
3. A photograph, taken at an angle to show the front and one side of the motorboat. The photo will not be returned.
4. A completed “**Application** for Bonded Certificate of Title”, dated and signed.
5. A **surety bond**, obtained from a bonding company or insurance agency licensed to do business in Nebraska, based on one and one half times the current value of the motorboat. The bond shall be in effect for three (3) years. (**Note:** The surety bond must be submitted to DMV within 30 days of the date of issuance.)
6. An application and title fee of \$20.00 if the manufacture date is **BEFORE** January 1, 1990.

An application and title fee of \$50.00 if the manufacture date is **ON OR AFTER** January 1, 1990.

These fees are not refundable.

All of the above original documentation must be submitted to the Nebraska Department of Motor Vehicles, Driver and Vehicle Records Division, 301 Centennial Mall South, PO Box 94789, Lincoln, Nebraska 68509-4789.

If a HIN plate is required, please also complete a HIN application and submit a \$20.00 fee.
